BUSINESS ARISING FROM THE MINUTES

- R. Layng garbage container C. Fenlong spoke with them, hasn't been delivered yet after two calls.

DELEGATION(S)

- D. Boyer, Pineview Principal - traffic concern. - D. Boyer - come to Council concerning a problem around Pineview every morning from George St. to parking lot, driving straight through to parking lot and from Wiltse St. straight into parking lot, high rate of concern for potential accidents or tragedy with walking students they have to wait until bell time to enter school grounds (9:10 a.m.) with no stop signs - no signage or direction. - D. Alguire – are you proposing stop signs on George and Wiltse Streets? – D. Boyer - not sure, proposal don't know what can be done there but currently not yielding they are straight through entering parking lot. -C. Fenlong - met with D. Boyer one other time to figure out a solution, it's a terrible design (the new parking areas), do not recommend a 3 way stop – suggest maybe would be stop on George St. and stop sign coming out of parking lot in front of the church on George St. – it's difficult where to put stop sign, no good visibility due to church at corner it would be trial and error to see if it would work – other parking lot I watched do you know how many arrows on that parking lot they are all over the place and every which way - why not a one way rather than all over the place – D. Boyer - flopped parking lot last year, its flow has improved but it's people off George St. entering or Wiltse St. and entering – those streets are problematic – C. Fenlong – there weren't problems before this new design and land purchase/extension, maybe George St. stop and Wiltse St. through way – D. Boyer - need to stop Wiltse St. too – C. Fenlong - would need one as well from parking lot – D. Boyer - all buses now enter on Wiltse St. so buses don't come up George St. to turn into parking lot. - A. Dancy - flashing red light student zone when school is in - C. Fenlong - a lot larger cost. - G.

Kearney – no left turn by fire hall and everyone has to come in other side by the church – have to come Wiltse St. – C. Fenlong - make George one way? Problematic. - D. Noonan - have you contacted the board? - D. Boyer - did, superintendent. - D. Noonan - it's terribly confusing, the parking lot looks like it is part of or an extension of the street. -T. Evans - any way to do a trial and error? temporary stop for a month or 2-3 weeks - C. Fenlong - would have to be six months to a year. - H. Scott - township and board need to get together to see what can and can't be done, get this straightened out. – M. Smith – stop on Wiltse St. and stop on George St. or yield on one of the two and maybe school board needs a curb on George Street. – R. Layng – similar to M. Smith - would it hurt to put a stop at Wiltse St. and see what happens with that - buses and vehicles, all have to stop there before they go across – M. Smith - one way stop – C. Fenlong – Wiltse Street is a main road – flow – George St. easier to stop, Wiltse St. if buses and vehicle are stopping you'll line up and block back to Elgin St. – G. Kearney - it is a school zone people always in a hurry shouldn't even be an issue – C. Fenlong - one question why are they waiting on Wiltse St why can they not enter school ground – D. Boyer - 9:10 supervision starts, they aren't permitted on school property until then - C. Fenlong - so now it's our problem and liability for the school board leaving kids on sidewalk — C. Fenlong - a curb at parking lot side of George would be winter issue – H. Scott - Township problem but school board problem as well, we need the two bodies together and make a recommendation we can accept. – D. Boyer - would have to see and time frame to put the pieces together for student safety. – H. Scott - a rough draft together D. Boyer, her facility supervisor and C. Fenlong. C. Fenlong - needs to read policies on it - D. Boyer - there aren't any school zone signs either. – R. Layng - crossing guard there maybe? It's not a crossing issue it's a wait on street for school entry. - T. Evans - what's the thought to C. Fenlong - make Wiltse St. one way street? Then to Wellington - C. Fenlong - easiest is talk with board is trial and error, stop street on George St. and see, but need to meet with the board – H. Scott – D. Boyer - can you arrange for the first of next week if it is big enough, issue to bring here it's big enough for the board to look at. -D. Boyer - will start tonight the meeting process. C. Fenlong - meet with them then a breakdown of what's going on after meeting to Council. – H. Scott - first step, the UCDSB personnel need to be there first hand to see the issues going on.

- K. Pattemore - ADHS Blue Party - Country Fair Parade Proposal - Prime Minister, grade 11 - Deputy A. Kennedy - expand our tractor parade tradition to include ATV's - we talked to OPP and are in favour - involved in our school and our principal and enthusiastic and excited.
